Russia's occupation of the Crimea and possible incorporation of Eastern Ukrainian regions has demonstrated Europe's vulnerability to Gazprom's energy power. What next for the Southern Corridor? Is Russia going to accept and tolerate infrastructure growth of the Caspian and other competitors south of its borders?
